# Aged Care Influenza Vaccination for Staff

From **1 May 2018**, Australian Government-subsidised providers of residential aged care are required to have in place a flu vaccination program that:

- provides staff and volunteers of the service with access to a free flu vaccination on an annual basis.
- actively promotes the benefits of an annual vaccination for their staff and volunteers, and for the health outcomes of care recipients.
- keeps records of the number of staff that receive a flu vaccination each year (whether or not under

### **How Clean is Your Stethoscope?**

A study published in *Infection Control & Hospital Epidemiology*, found that stethoscopes carried by healthcare practitioners are loaded with diverse bacteria, including some that can cause healthcare-associated infections (HAI). The research also reviewed the effectiveness of cleaning methods, finding a standardised approach to be superior for removing bacteria compared with various approaches employed by healthcare practitioners.

"This study underscores the importance of adhering to rigorous infection control procedures, including fully adhering to CDC-recommended decontamination procedures between patients or using single-patient-use stethoscopes kept in each patient's room," said Dr Ronald Collman, Professor of Medicine, Pulmonary, Allergy and Critical Care at the University of Pennsylvania Perelman School of Medicine and senior author of the study.

# Aged Care National Antimicrobial Prescribing Survey (acNAPS)

acNAPS is an annual survey, which monitors infections and assesses antimicrobial prescribing practices for people in residential aged care. In 2019 it can be undertaken on any single day between *1 June and 31 August 2019*.

Participation in acNAPS assists:

- aged care homes and multi-purpose services identify how they can improve the safety of care for residents; and
- facilities meet the Australian Aged Care Quality Standards, which require
  demonstration of 'practices that promote appropriate antibiotic prescribing
  and use to support optimal care and reduce the risk of increasing
  resistance to antibiotics'.

Previous acNAPS surveys have identified documentation of the reason for prescribing an antimicrobial, high use of topical antimicrobials and prolonged use of antimicrobials, as areas for improvement.

## Community Associated Methicillin-Resistant Staphylococcus aureus (CA-MRSA)

The CA-MRSA program regularly reviewed by a CA-MRSA Expert Advisory Group (EAG), the most recent review occurring in May 2018. The major change was to cease direct communication (via letter) with all cases and adopt other approaches for informing healthcare providers and increasing awareness of the magnitude of problem. One recommended method to raise awareness is to report rates by region, on the WA Health corporate website with links to current CA-MRSA Information for Clinicians. This approach was endorsed recently by the Director General of Health. CA-MRSA rates, by region, is now available on WA Health website.

the approved provider's fluvaccination scheme).

These requirements can be found in the Quality of Care Principles 2014 and the Records Principles 2014.

The Aged Care Quality and Safety Commission (the Commission) which

commenced operation on 1 January

2019, assesses a provider's compliance with the Accreditation Standards. Compliance with the flu vaccination program is assessed by the Commission through the Accreditation Standard's expected outcomes on Infection Control and Regulatory Compliance. Residential aged care providers also need to demonstrate how they have promoted and informed their staff and volunteers of the benefits of vaccination and the steps taken to encourage staff to receive a vaccination. It is also a requirement to maintain records related to their vaccination program, including the number of staff who have received the flu vaccination. Should a provider fail to meet an expected outcome the Commission will notify the Department of Health who will then consider whether to take any regulatory action.

# Air Handling and Water System Review for Western Australia

As part of the Implementation of the Public Health Act (2016), the Department of Health (DOH) must review the *Health (Air-Handling and Water Systems) Regulations 1994* which are designed to protect the public from the spread of air-borne disease such as Legionnaire's disease.

As part of the review of the Air-Handling Regulations, the DOH must determine whether this public health risk must continue to be regulated under the framework provided by the Public Health Act, or whether the risk can be effectively managed through an alternative approach such as a guideline or other legislation.

The DOH has prepared an options paper entitled "Air-Handling and water systems review" examining 4 options for WA. The discussion paper can be downloaded from the consultation webpage:

#### **Hard Surface Disinfectants**

The TGA has advised that the way hard surface disinfectants are regulated has changed.

"Hard surface disinfectants have recently been down-regulated as a result of the reform activities endorsed by Government from the Future Regulation of Low Risk Products Review. This included:

- Downregulating Registered disinfectants entries on the Australian Register of Therapeutic Goods to become Listed entries, and Listed disinfectants are now exempt, and
- Pre-market review of listed disinfectants will only be conducted on new ingredients (that are active) and/or new specific claims".
